**Answer all questions clearly.** Speak loudly so everyone can hear your answer.

**Ask to have the question repeated.** If you are unsure or confused say "I do not understand the question."

**Try to relax.** Take a deep breath. Drink some water. It's OK to go to the bathroom.

**Take your time to answer each question.** It is OK to think about your answers.

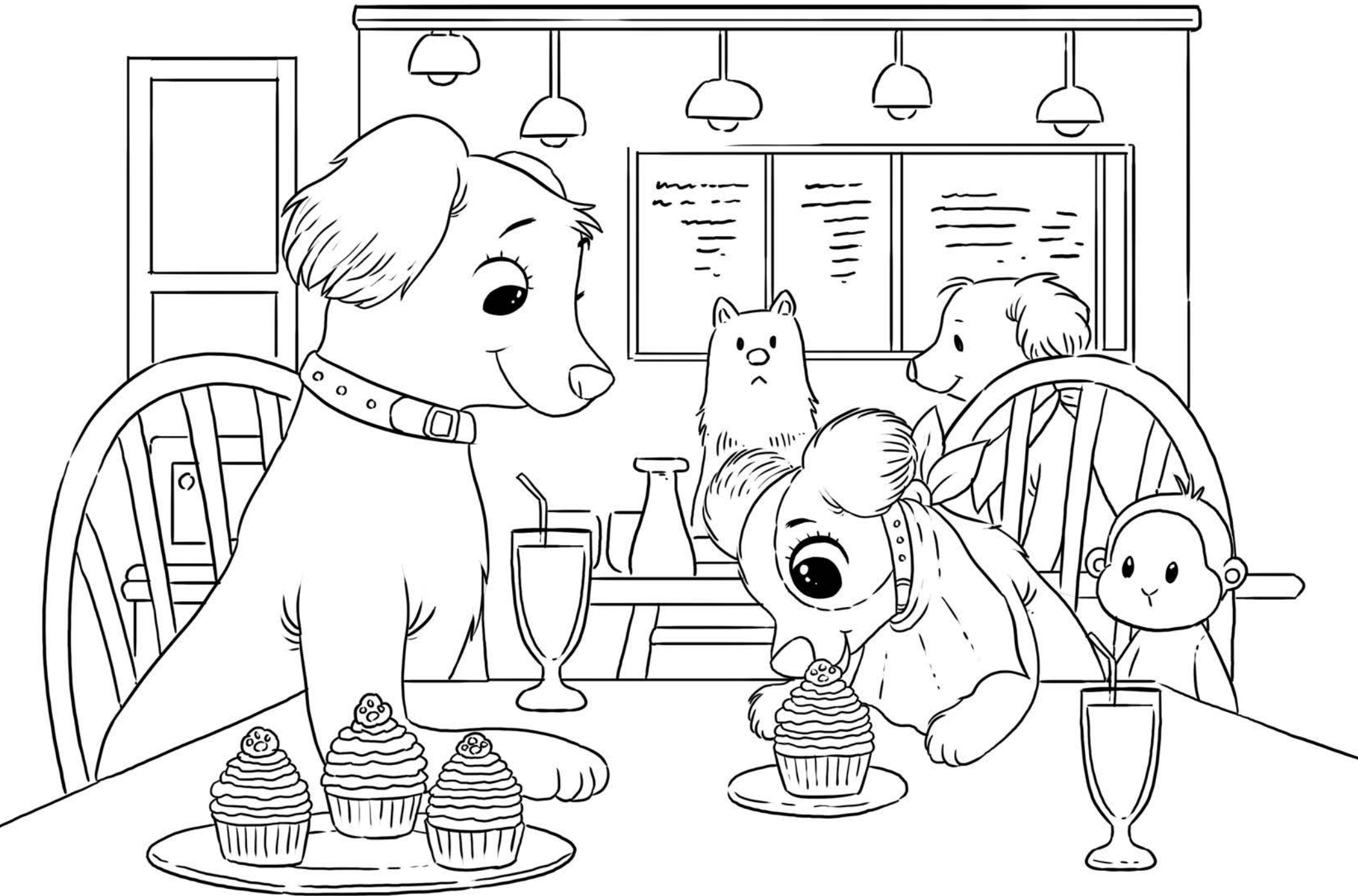
**A support person can be with you.** Ask Victim Services for more information.
